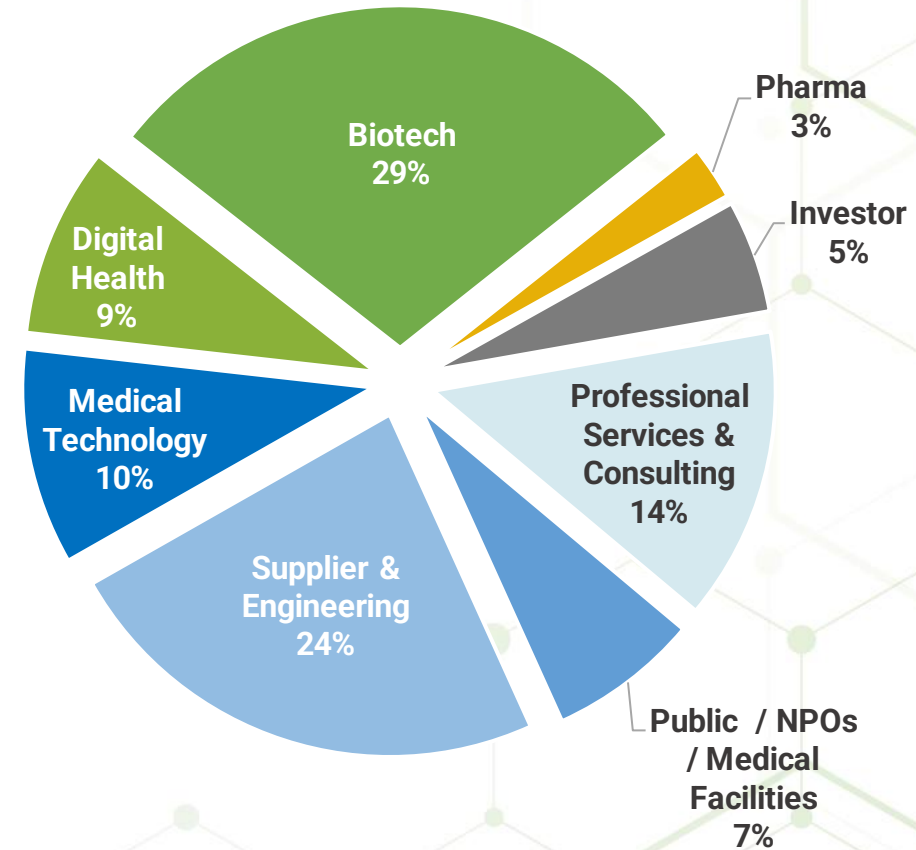

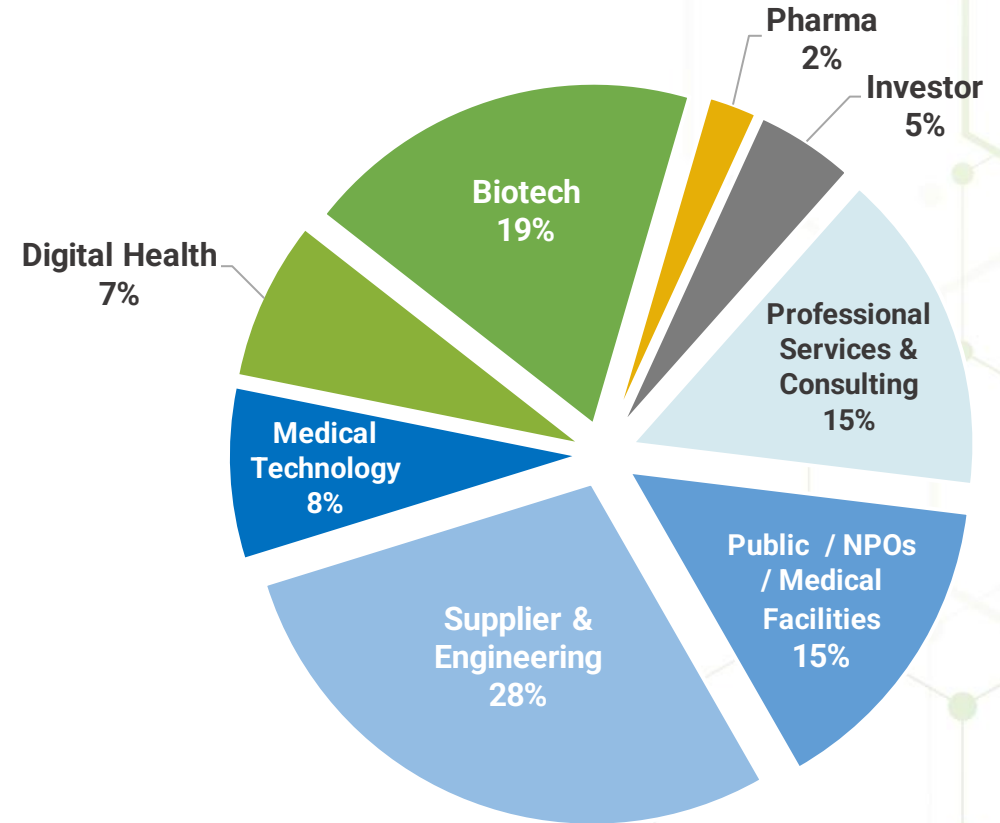
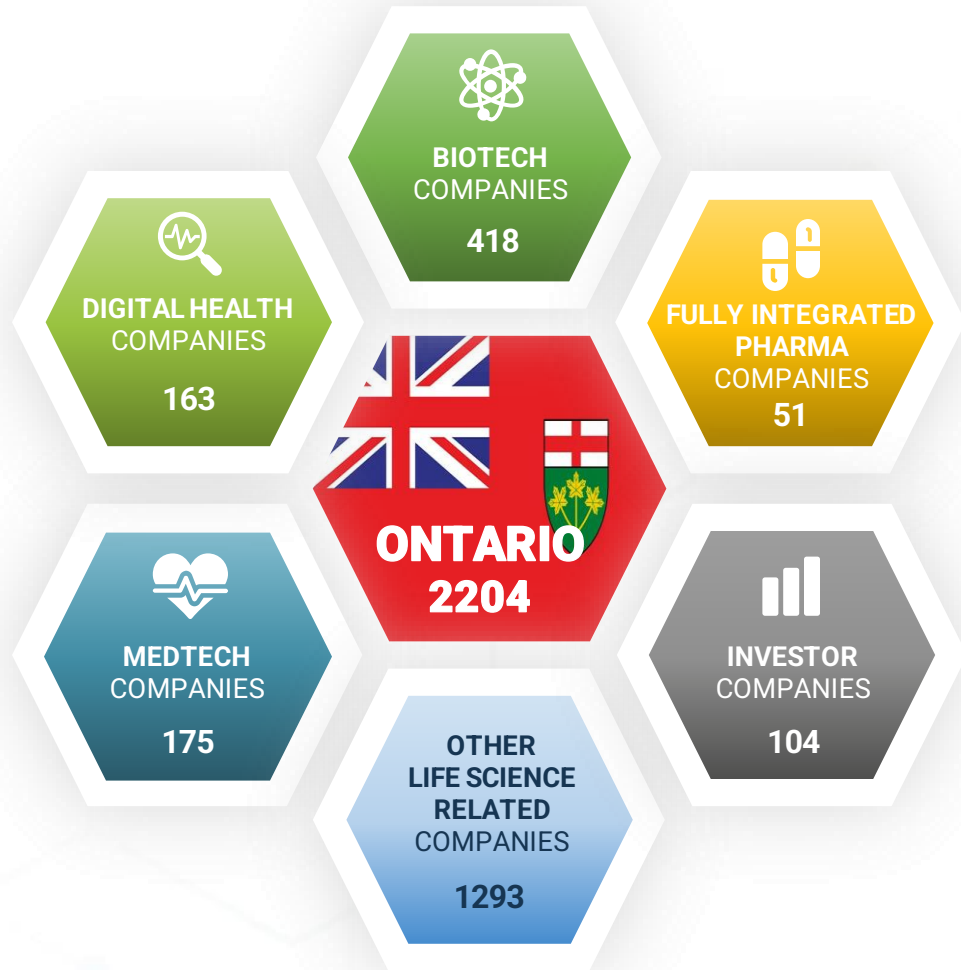
## NUMBER OF COMPANIES BY SECTOR

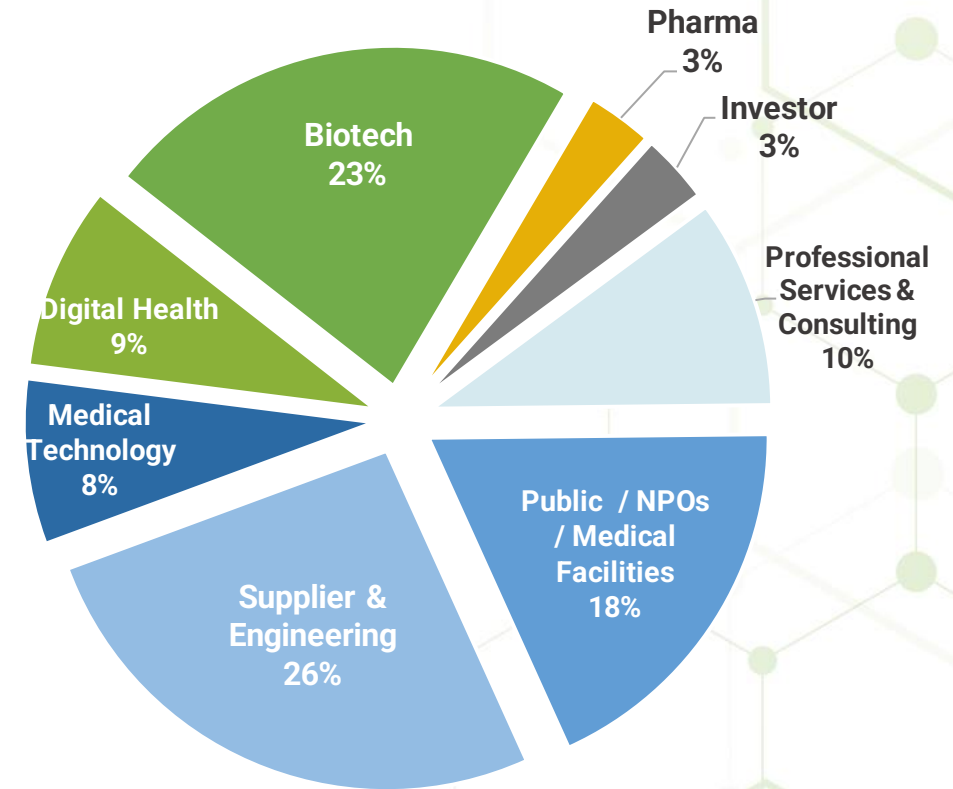
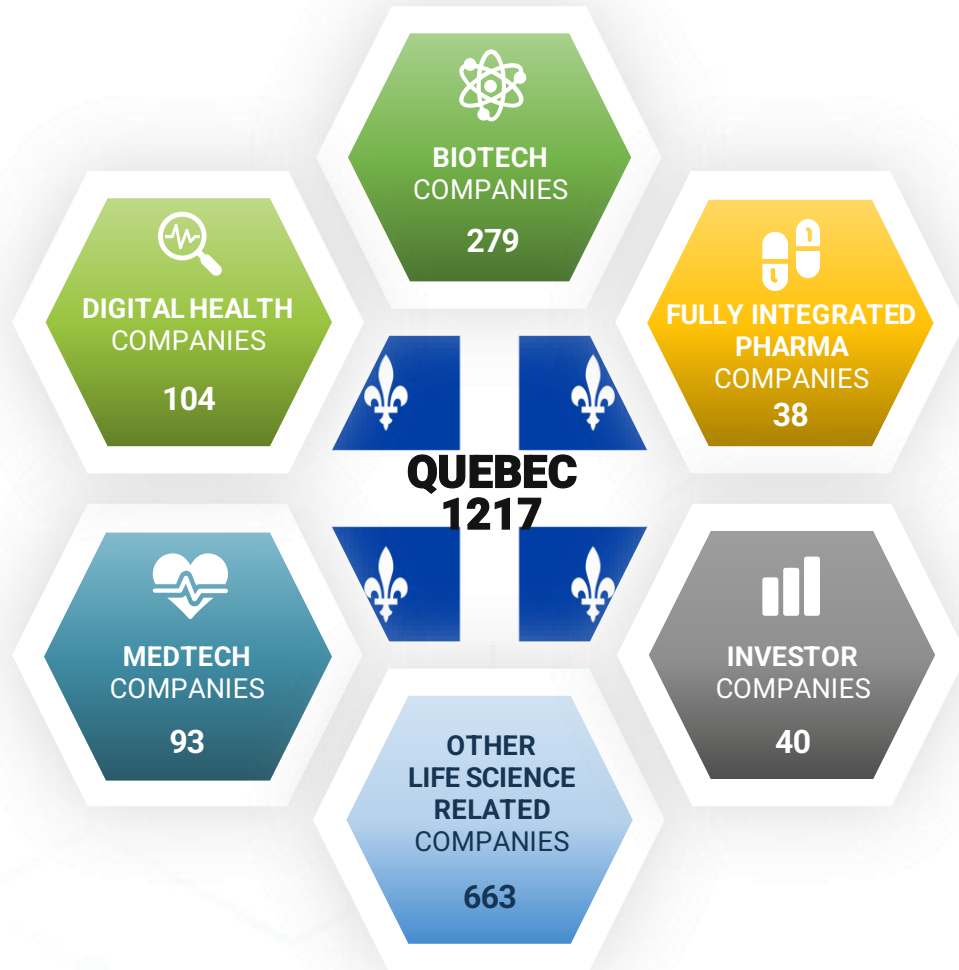
## NUMBER OF COMPANIES IN ONTARIO BY SECTOR

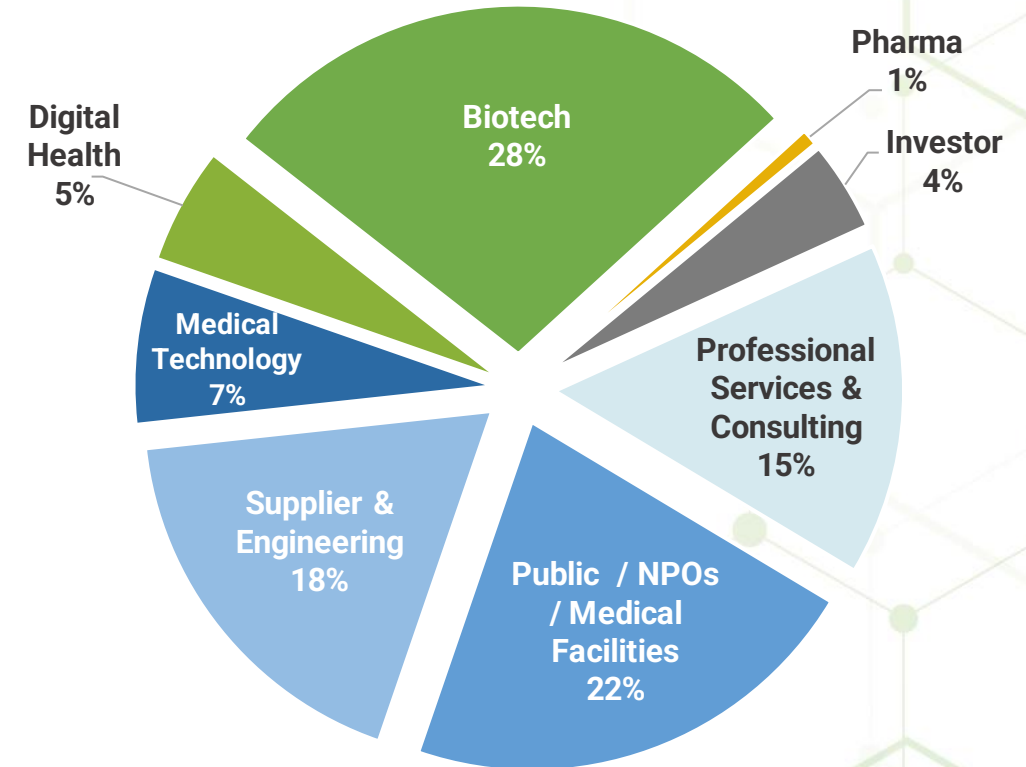
## NUMBER OF COMPANIES IN QUEBEC BY SECTOR

## NUMBER OF COMPANIES IN ALBERTA BY SECTOR

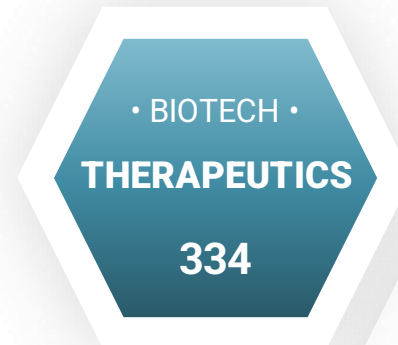
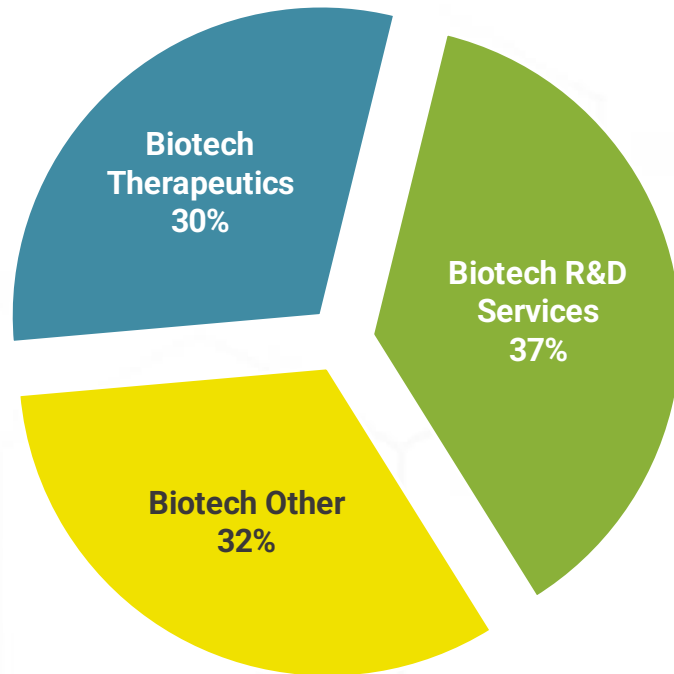

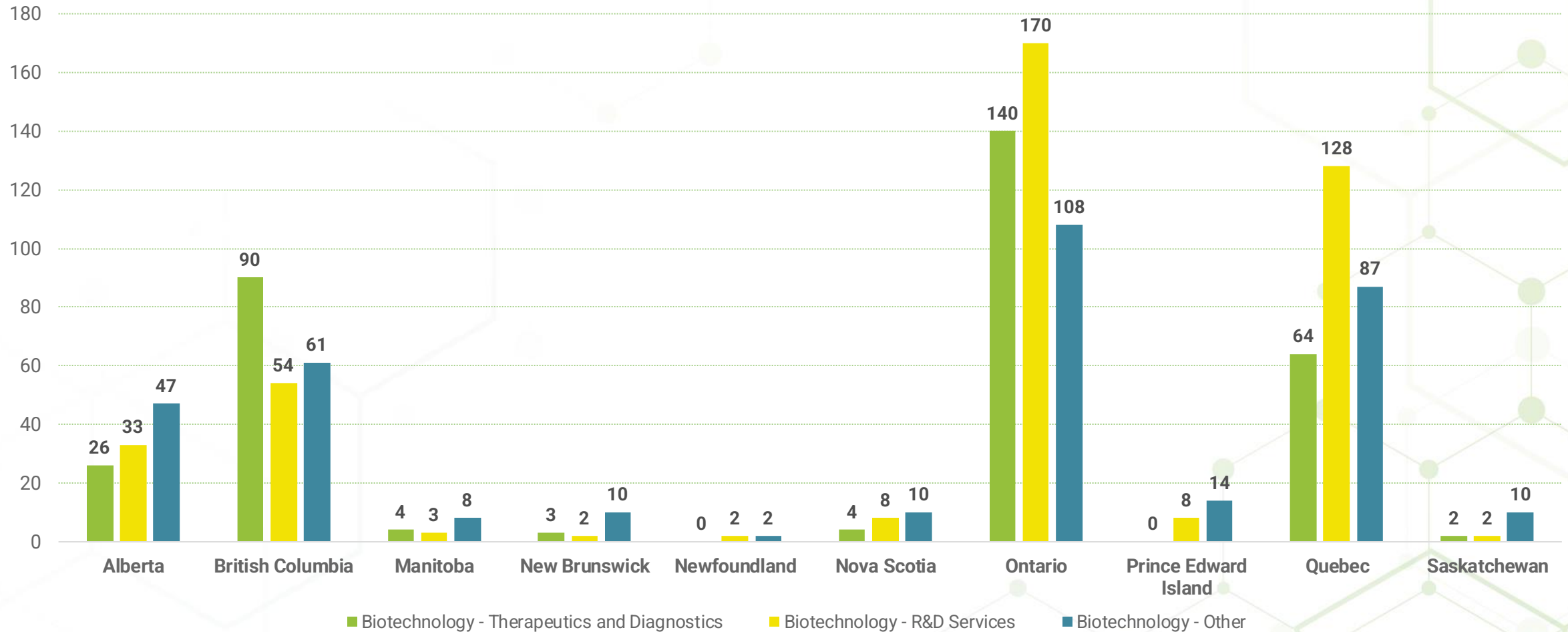

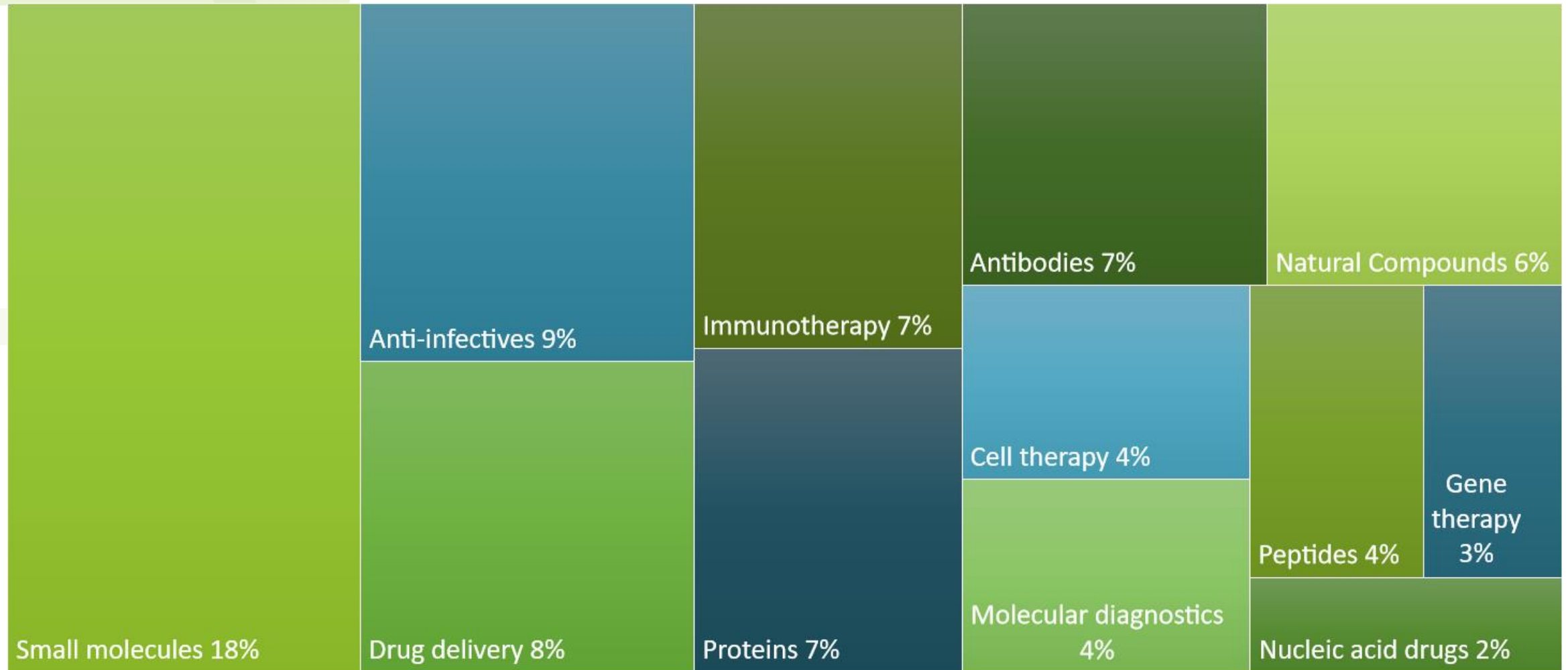

AS PERCENTAGE OF TOTAL NUMBER OF BIOTECH - THERAPEUTICS COMPANIES

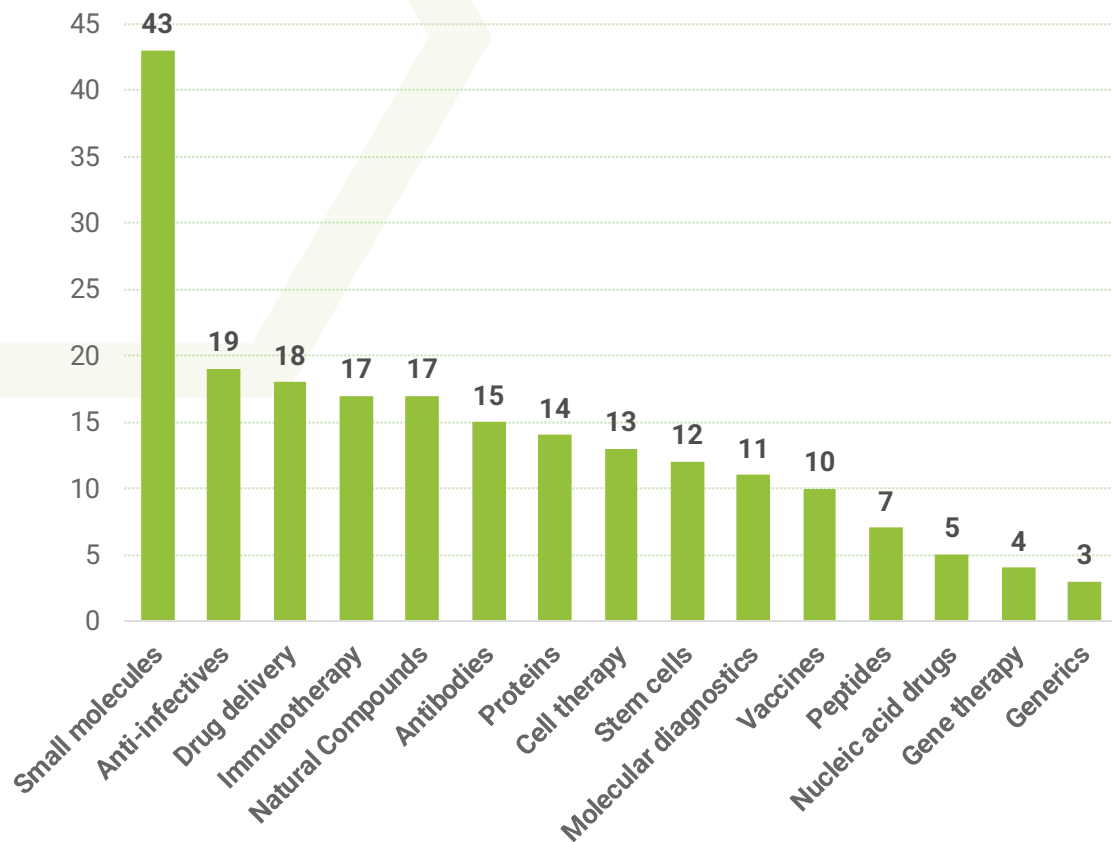

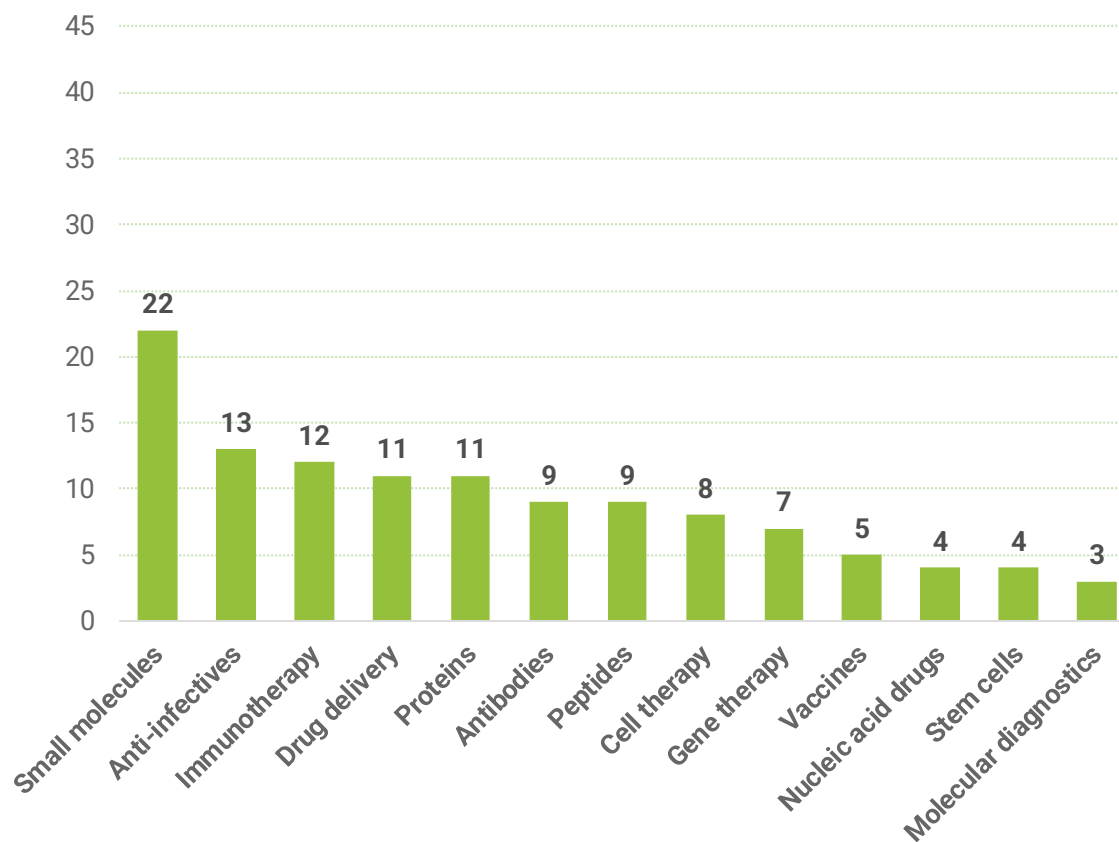

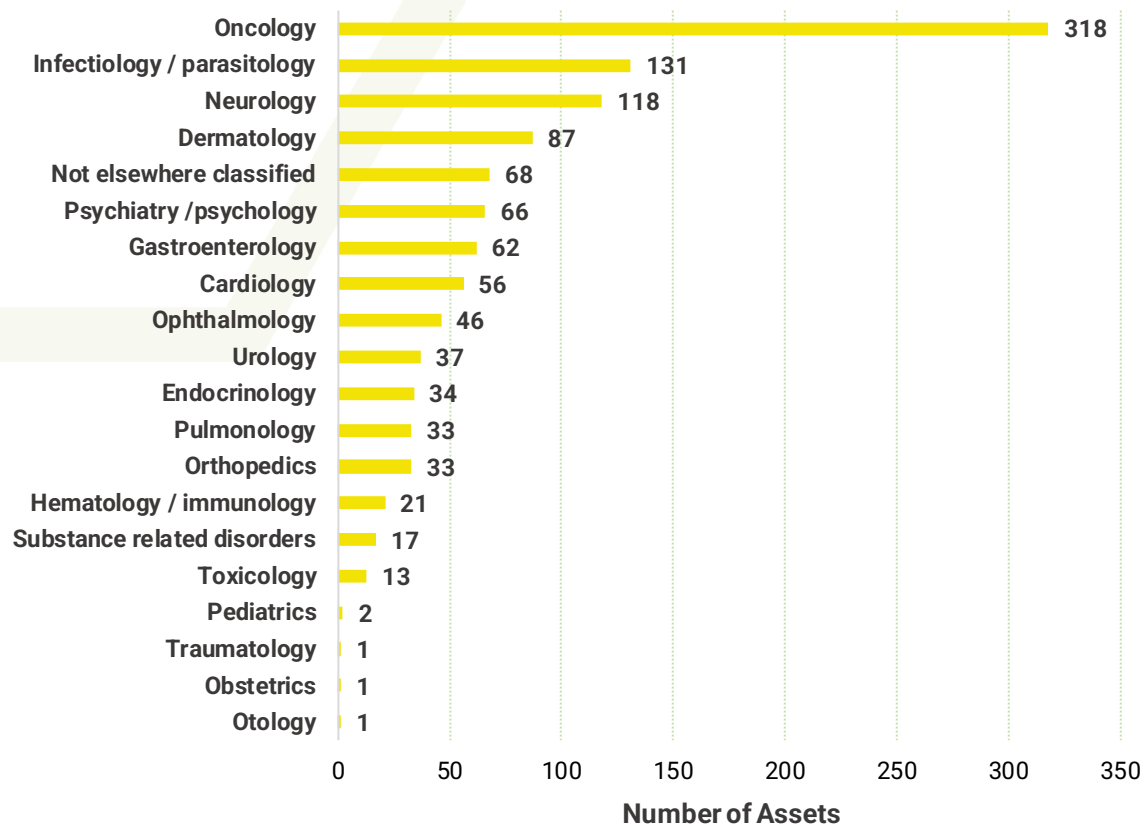

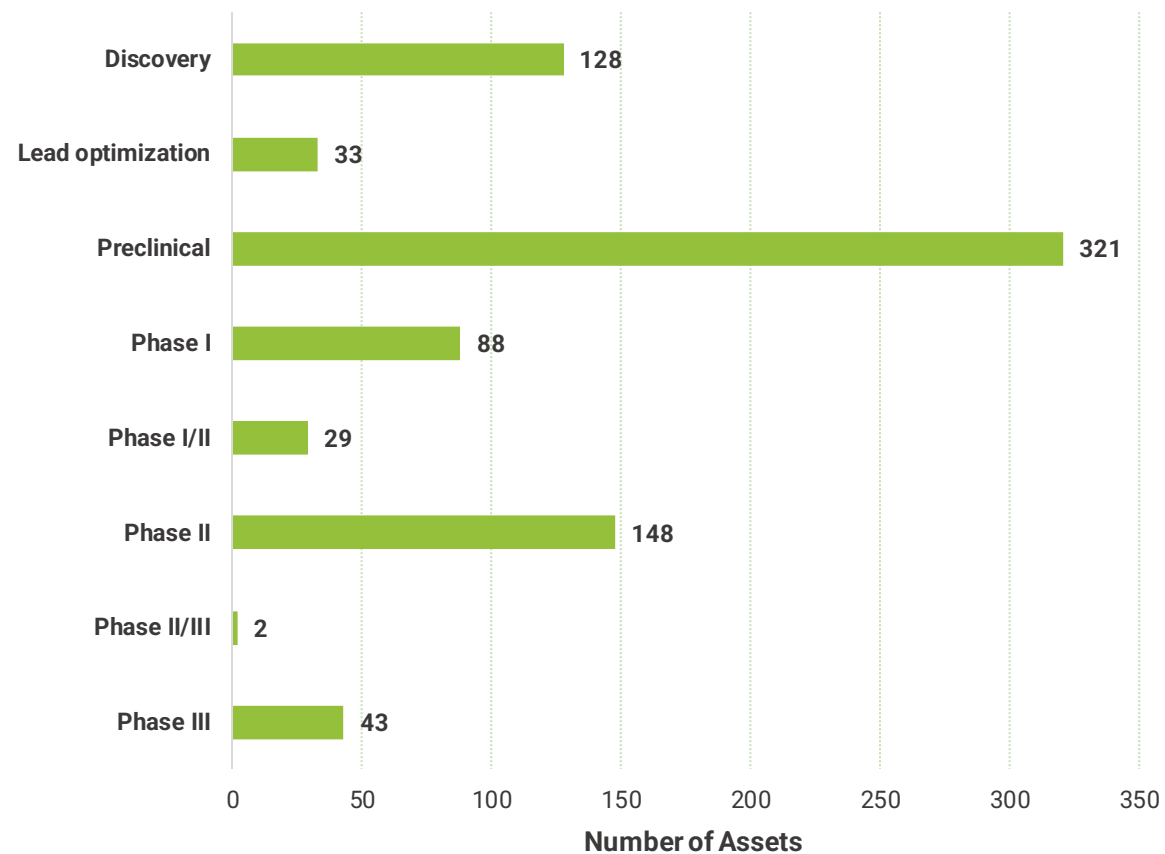

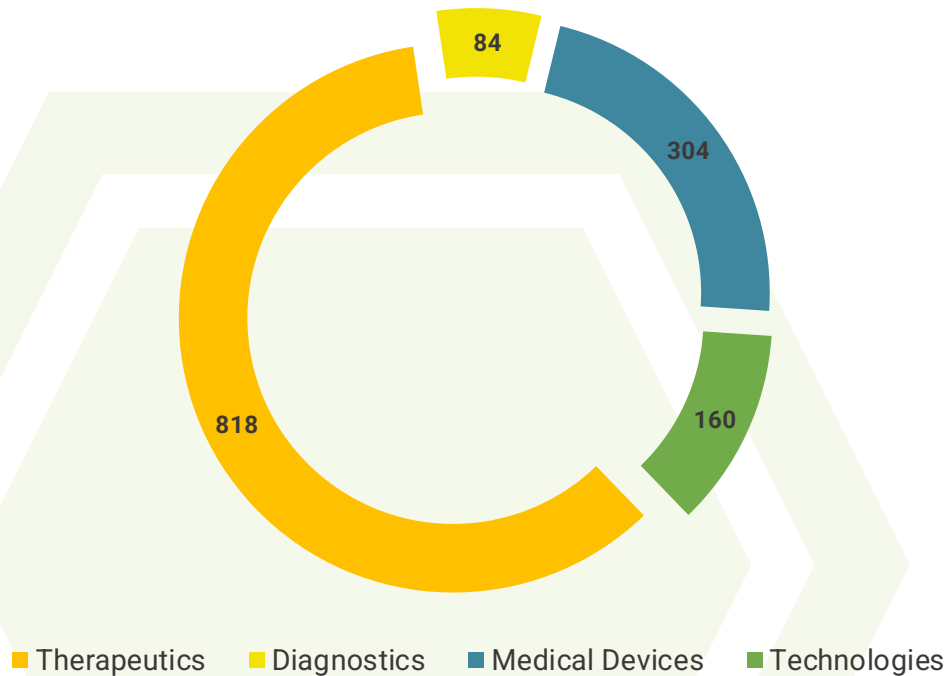

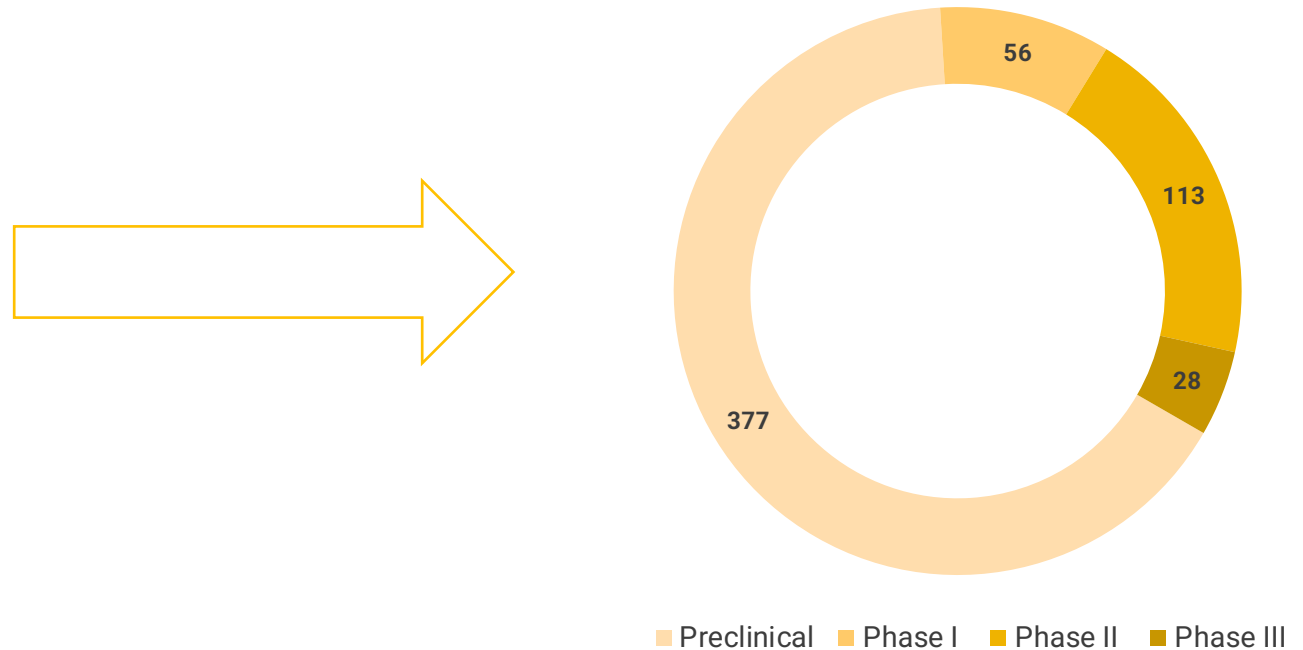

### THERAPEUTICS IN DEVELOPMENT BY DEVELOPMENT PHASE

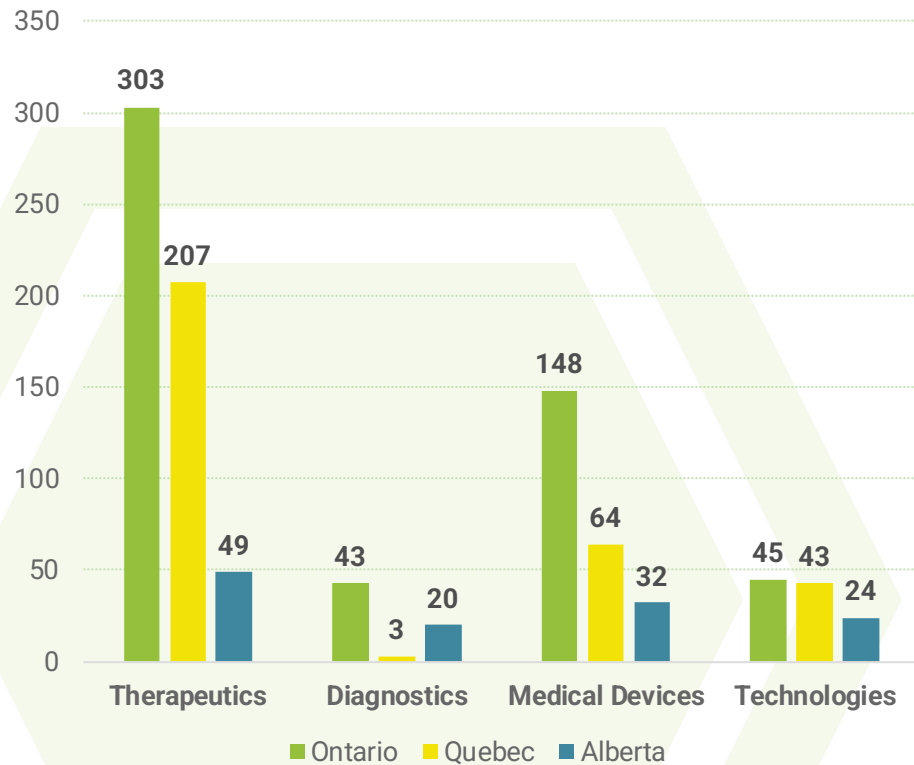

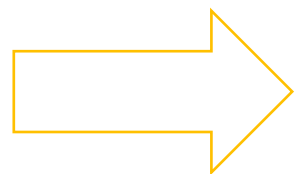
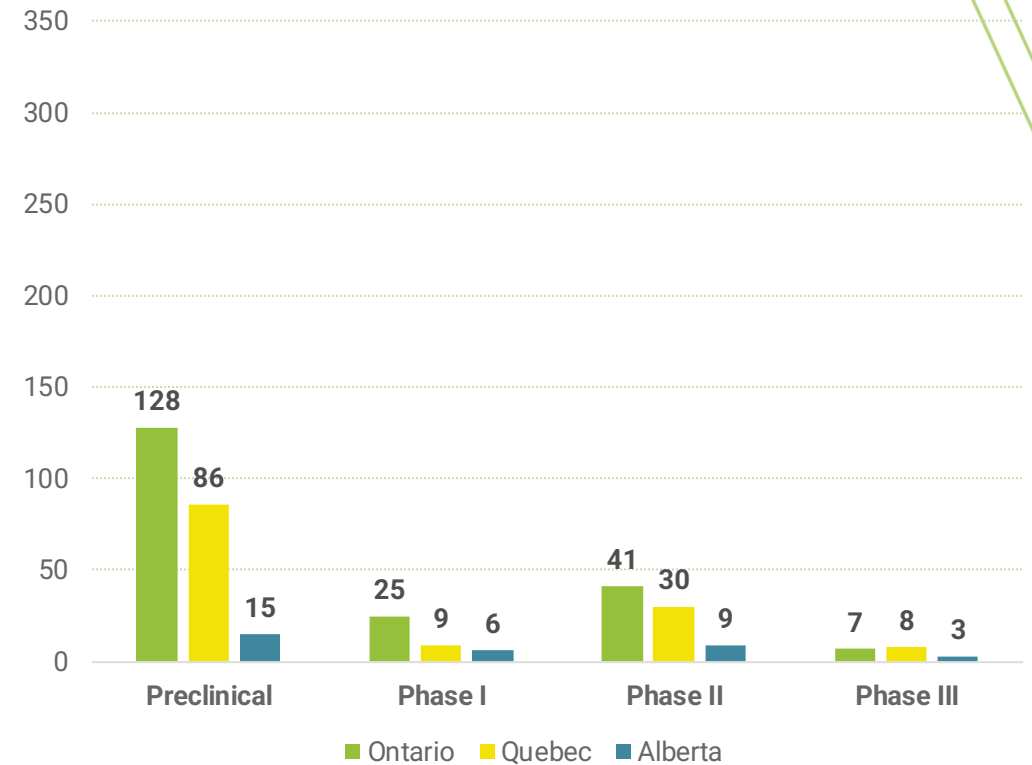

### BY ASSET CLASS



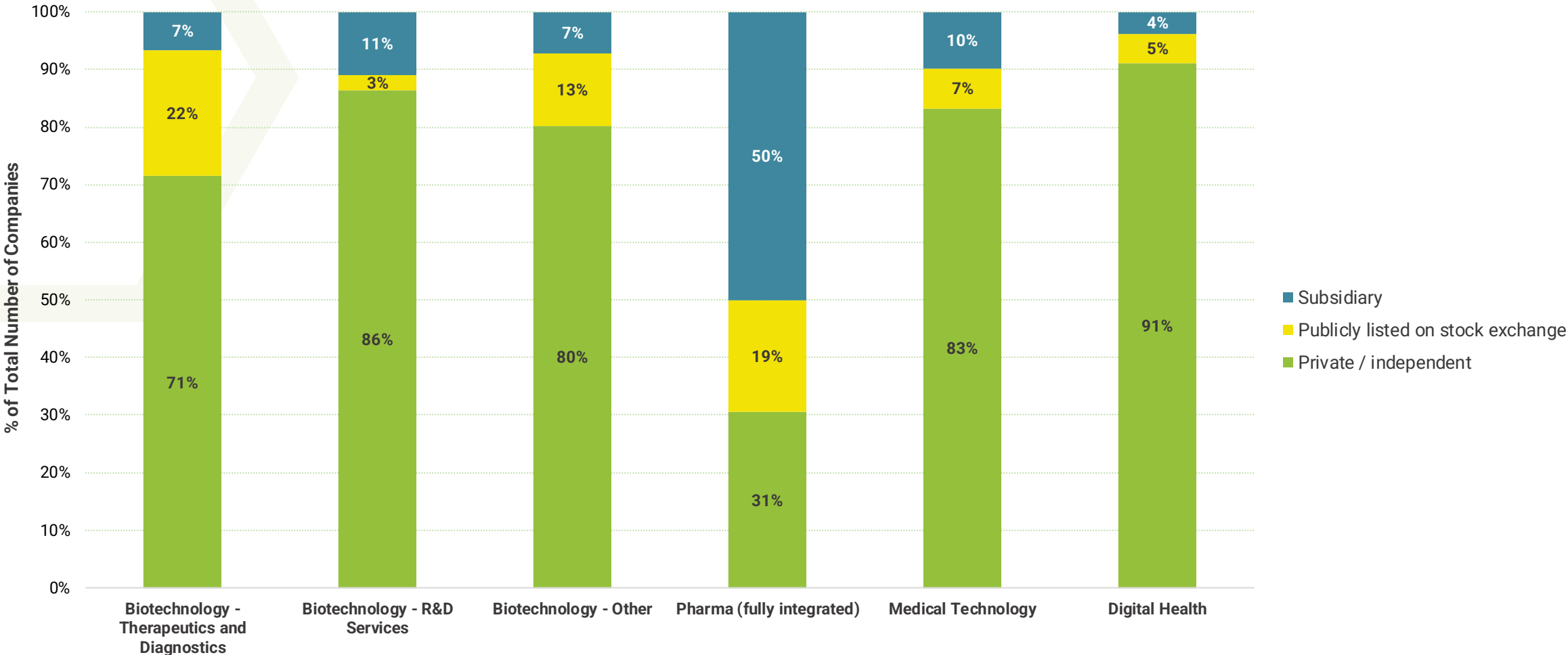

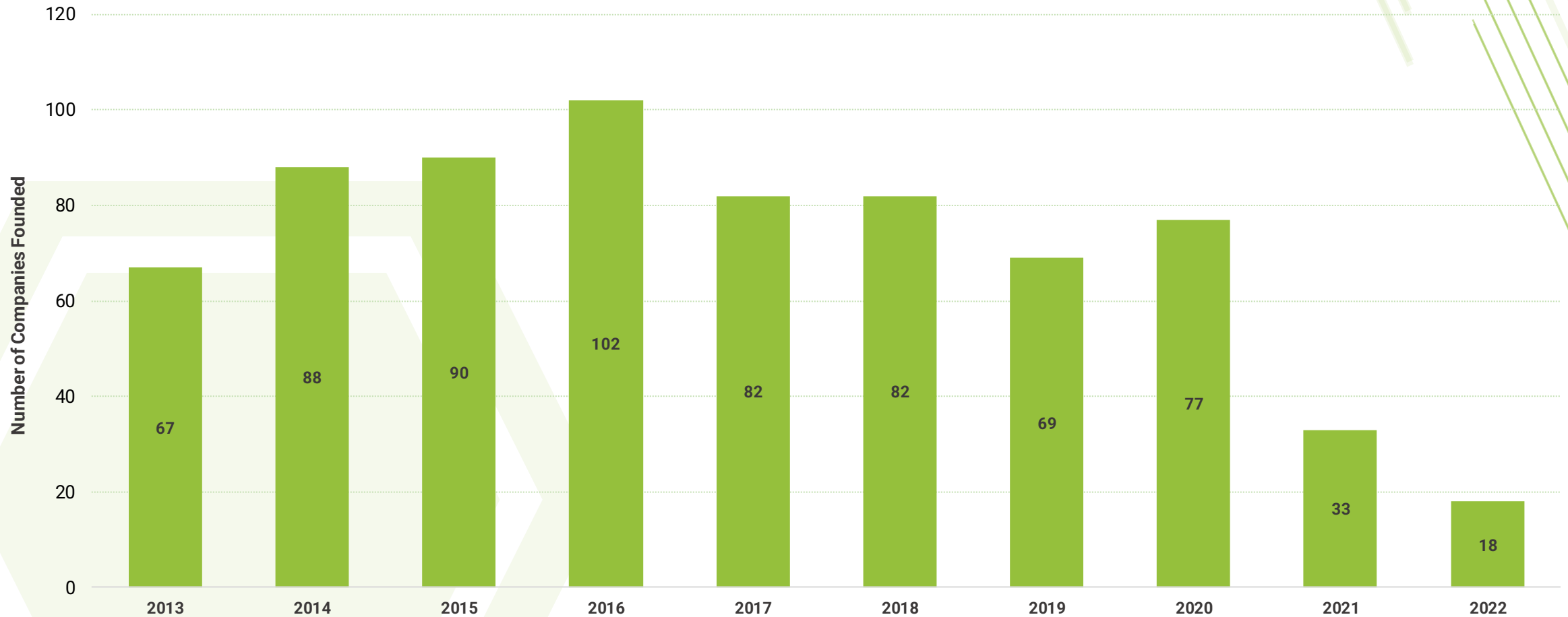
## PERCENTAGE OF TOTAL NUMBER OF COMPANIES BY OWNERSHIP AND SECTOR

NUMBER OF LIFE SCIENCE COMPANIES FOUNDED BY YEAR | 2013-2022



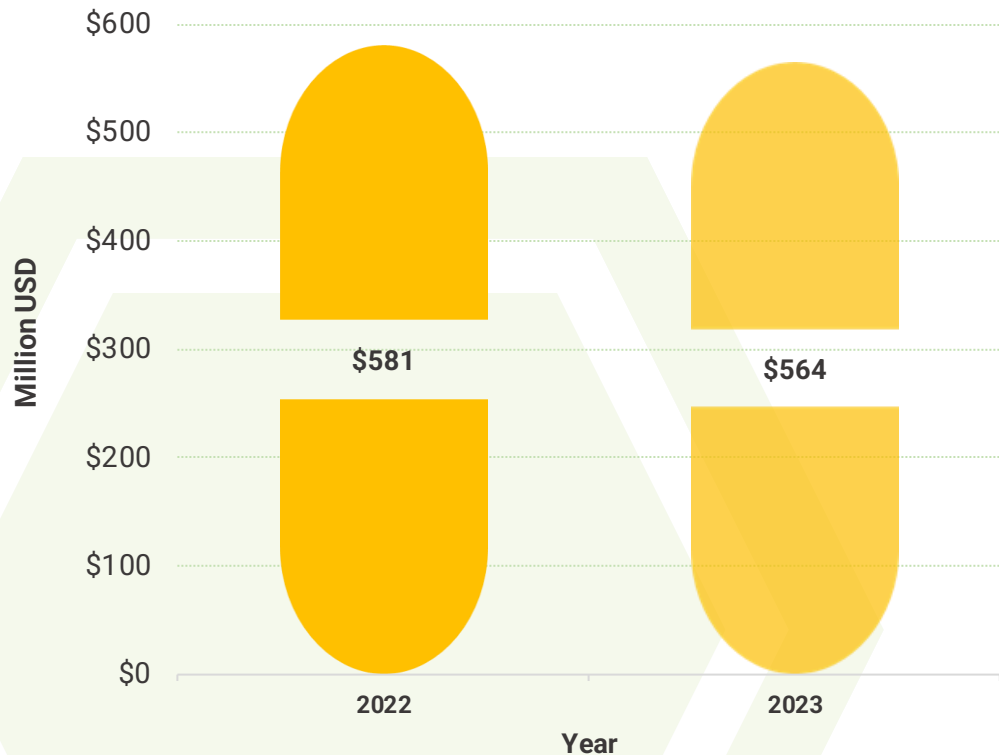

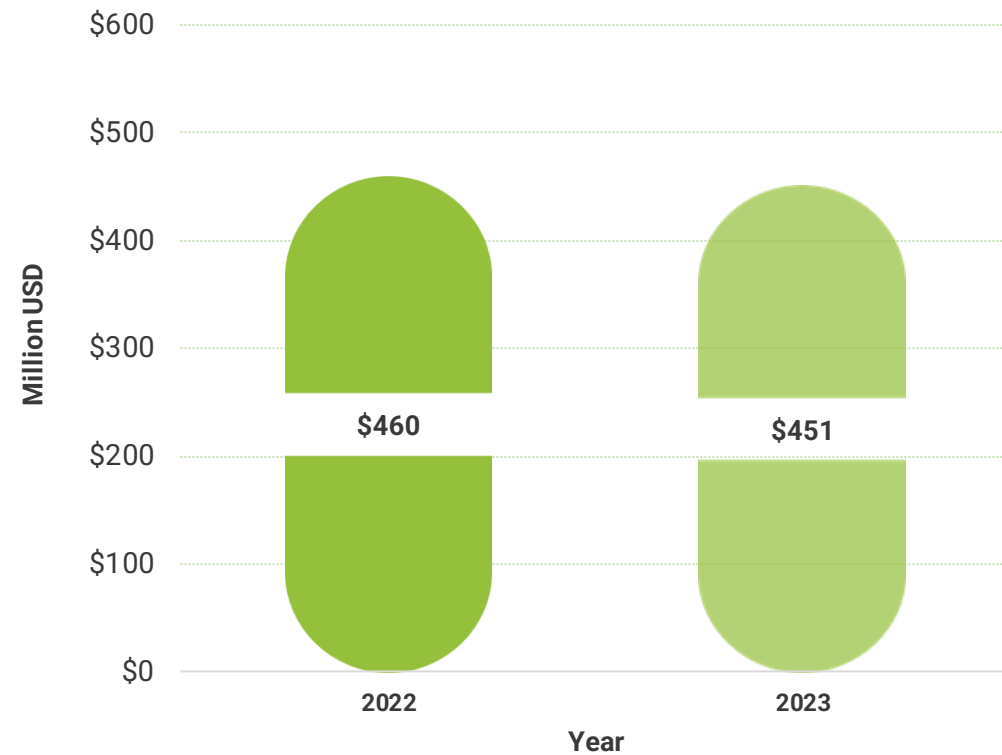

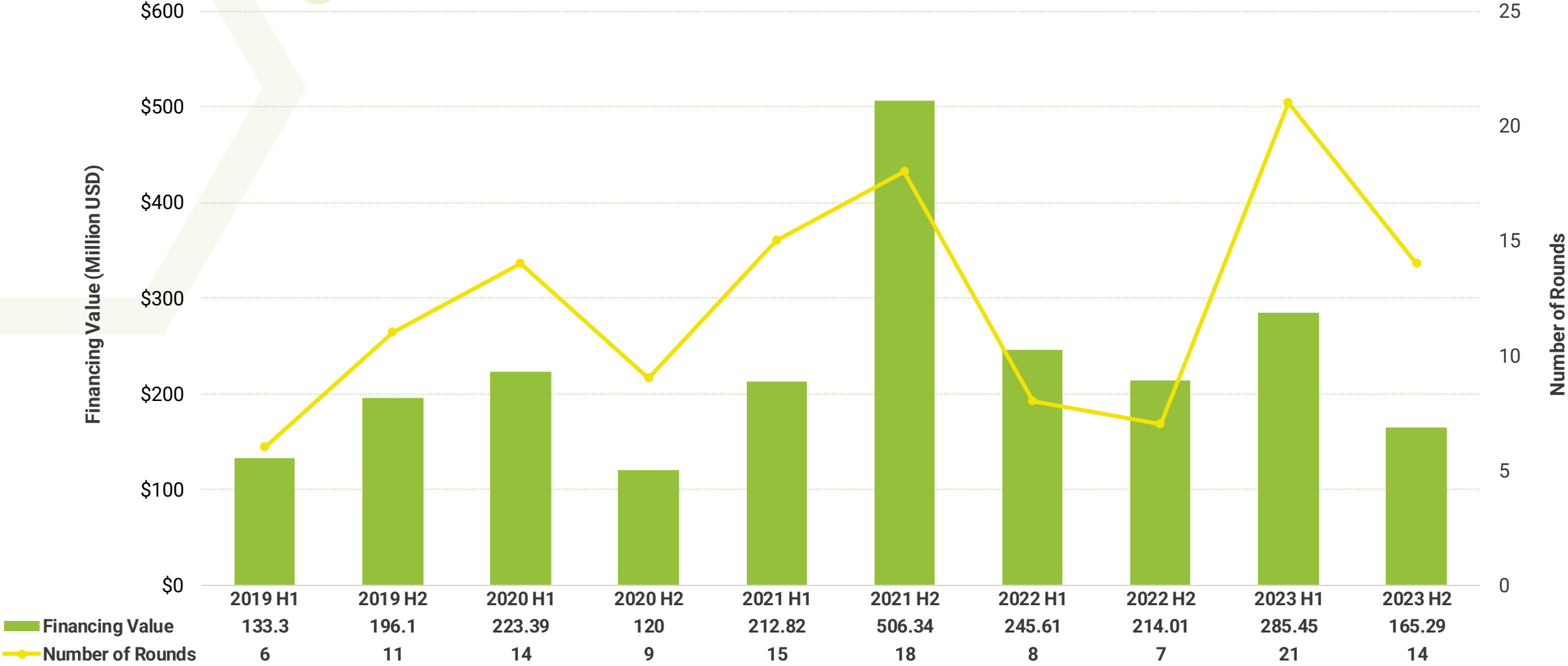

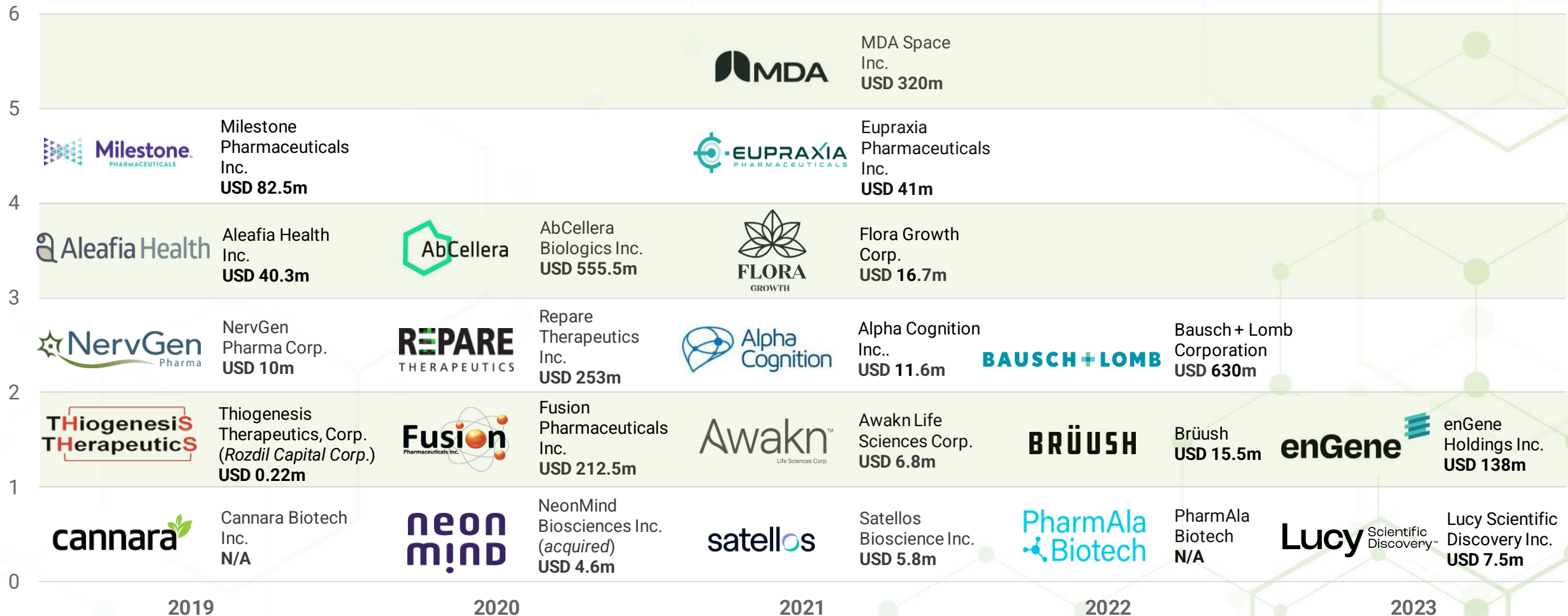
